Historic Landmarks and District Tax Credit	Available for historic properties in Baltimore City and National Register Historic District and individual Baltimore City and National Register Landmarks. Offsets any increase in Baltimore City's taxes that occurs following a substantial rehabilitation project that has been aprroved by CHAP. Home Improvement Property Tax Credit	Homeowners may receive a 5-year tax credit on the additional assessed value of the ir home due to recent improvements. Homeowner's Tax Credit	Homeowners whose combined gross household income is less than \$60,000 may receive a tax credit that limits the amount of property taxes. Homestead Property Tax Credit	Protects homeowners, regardless of age, income, or prorty value from annually spiking tax bills on the home they live in. Homeowners need only to apply once.	State Department of Assessments and Taxation (410-767-2165
Maryland Home Credit Program	Provides a federal tax credit to eligible homebuyers. This incentive can save a homebuyer tens of thousands of dollars over the life of the loan. The tax credit may be claimed annually. The value of the credit is equal to 25% of the value of the mortgage interest payments (up to \$2000) paid each year for the life of the loan. Maryland Home Owners' Property Tax Credit		
Mayland Sustainable Communities Tax Credit Program	Available to "certified historic structures," which are properties individually listed in the National Regsiter of Historic Places, contributing to a National Regsiter Historic District, or a locally designated structre or contributing resource to a local historic district that MHT determines to be eligible for the National Register. This is one-time state income tax credit equal to 20% of qualified rehab expenditures and is capped at \$50,000 in a 24 month period. There is a minimum of \$5,000 of eligible expenses to qualify. Resident Retention Tax Credit	Desiogned to encourage buyers to purchase their second (third, fourth, etc.) home in Baltimore City. This incentive provides a five-year proprty tax credit in the following amounts: Year 1: \$1000, Year 2: \$900, Year 3: \$800, Year 4: \$700, Year 5: \$600.
