## **Cancellations and Refund Policy**

GBBR may cancel courses due to low registration up to two days prior to the date of the class. In the event that GBBR must cancel a course, all those who registered will be contacted and notified of the cancellation and you will be offered the option of receiving a refund or transferring your payment/credit to another class.

**GBBR does not issue refunds for education courses**, except when the course is cancelled by GBBR. Individuals who miss a program without submitting written notification 24 hours prior to the course date will be charged for the course.

If you find it necessary to cancel your course registration, you must submit a notice in writing at least 24 hours prior to the course. Persons who are able to document compliance with the written notification requirement will receive a credit voucher that may be applied to any future education program, or as a credit toward annual dues or to purchase retail items from the GBBR REALTOR® Store.
